## **INSTRUCTIONS TO AUTHORS**

#### MANUSCRIPT PREPARATION

The preferred format of all manuscript is MS Word. Illustrations (figures) and images must be inserted in the manuscript at the position they should appear when published. Authors should prepare their manuscripts according to the instructions and specifications listed below and check the manuscript for conformance before submitting it for publication.

**Page format:** Manuscript should be prepared as word processing documents on A4 concisely typewritten in 1.5 spaces in A4 sized sheets, leaving 1 inch margin all four sides.

#### **Fonts:**

Times New Roman and point size should be 12.

Title: 16pt bold uppercase

Main headings: 14pt uppercase,

Subheadings: 12pt bold lowercase.

**Tables:** Tables should be numbered consecutively using Arabic. Each table should have an explanatory caption which should be as concise as possible.

**Figures:** All figures must be numbered with Arabic numerals.

#### All the figures and tables should be placed at appropriate in the text itself.

## **ARTICLE TITLE:**

The title should be as short, informative and precisely indicate the nature of the work in the communication. Title should be of 16pt bold uppercase. It will contain full first name, initial(s) for middle name(s) and full last name. The Corresponding Author must be listed first and marked with an asterisk\*. Authors' affiliations should be indicated in this section.

#### **ABSTRACT:**

Should start on a new page after the title page and typed in single space point. It should give concise and factual information about the purpose and content of the paper. An abstract should have 150- 250 words.

## **KEY WORDS:**

Immediately after the abstract, provide a maximum of 4-6 keywords

## **INTRODUCTION:**

Introduction should indicate the subject of the subject and novelty of research work. It should provide sufficient background information, goals of paper and finally the organization of paper

#### **MATERIALS AND METHODS:**

The section should include sufficient technical information to allow the experiments to be performed. The source of Excipients, chemicals and drugs may be given. Units and dimensions should be expressed according to the metric system and SI units. The permission from animal ethical committee should be mentioned.

## **RESULTS AND DISCUSSION:**

**This segment must be** described as concisely as possible and should not contain technical details. It should contain the findings and interpretation of the results presented in the form of tables, figures and photographs.

## **CONCLUSION:**

Conclusion should be short, representing the summary of the important findings and facts.

### **ACKNOWLEDGMENTS:**

The source of any financial support and technical assistance (Institute/ colleagues) received for the work and notes of appreciation should appear in this section

## **REFERENCES:**

The Vancouver style of referencing is preferred. A number in superscript format, placed in the text of the essay, indicates the relevant reference.

Tables should be created using Microsoft Word table formatting. All figures should be cited in the text. File formats accepted are Microsoft Word, PNG, JPEG, TIFF, BMP

#### **REVIEW ARTICLES**

Review articles should not be more than 25 pages and contain comprehensive coverage of relevant literature. Review articles should preferably be written by researchers who have comprehensive knowledge of the topic. Review articles need not to be divided into sections such as Materials and methods, and Results and discussion. All format requirements are similar to those applicable to Research papers.

#### SHORT COMMUNICATIONS

The Journal publishes innovative findings, preliminary data or studies that did not yield enough information to make a full paper as short communications (Not more than 10 Pages). Communications should not have subtitles such as Introduction, Materials and Methods, Results and Discussion- all these have to be merged into the running text.

## **ETHICAL MATTERS**

Authors should seek approval from the appropriate Ethical committee in accordance with "Principles of Laboratory Animal Care" for the usage of experimental animals and human subjects in their research. The Method section of the manuscript should include a statement to prove that the investigation was approved and that informed consent was obtained.

#### **DECLARATION OF INTEREST**

All authors are requested to disclose any actual or potential conflict of interest including any financial, personal or other relationships with other people or organizations.

### **COPYRIGHT**

Authors would be required to sign a Copy Right Transfer Agreement (CTA form) once the manuscript is accepted. The corresponding author can download the CTA form and send the scan copy after signature to the journal.
